Rhona asked for mobile phones to be switched off and that if anyone had not yet signed in that they make sure they do so before leaving. Also there was a slight change to the running order i.e. items 9 and 10 would take place before the prize bingo.

Rhona went on to welcome everyone and thanked them for coming tonight, thanks were given to our Management Committee for giving up their time during the year to attend meetings and training sessions and to staff for all their help with all the preparations and arrangements for tonight.

Rhona made the annual appeal for new Committee members and asked if anyone wanted to get involved, to get in touch with any of the Committee or Knowes' staff for information.

Rhona talked about the new "Good Neighbour Award 2019" that we are running. We are looking for nomination of tenants who have gone out of their way to help others and who have shown kindness and consideration. Rhona advised that the closing date for nominations is 31st October and nomination forms can be collected from the office or downloaded from our website

To end her report, Rhona again thanked everyone for coming along and to the staff for their efforts in organising the meeting and to Kevin Booth, Alexander Sloan, David Robbie, The McDougall Group and to Jaclyn Brady for supplying the buffet

3.0 <u>Minutes of Previous</u> Annual General Meeting 4th September 2018

3.1 Approval for Signature

Councillor Lawrence O'Neill noted that he was recorded in the minute as a guest, when in fact he is a Share member.

Thereafter the minute of the last Annual General Meeting held on 4th September 2018 was agreed as an accurate record. Proposed by Billy Stevenson and seconded by Katie Devaney.

3.2 Matters Arising

There were no matters arising.

4.0 Statement of Accounts – Alexander Sloan

4.1 Kevin Booth of Alexander Sloan, Chartered Accountants was present to deliver a report on the financial position of Knowes Housing Association during the year ending 31st March 2019.

Mr Booth explained that it is the Management Committee's responsibility to ensure that proper accounts are prepared and that it is the job of the auditors to review these accounts and give an opinion to the Share Members on whether the financial statements are accurate.

He went on to give a summary of the key points within the accounts, advising that the balance sheet within the financial statement represents our assets and liabilities and that the Association continues to have a strong balance sheet.

Mr Booth stated that the opinion given by Alexander Sloan is that the financial statements give a true and fair view of the Association's affairs as at 31st March 2019 and of its surplus for the year and that the statements have been properly prepared in accordance with generally accepted accounting practices.

Mr Booth asked if members had any questions/queries on the accounts, of which there were none.

The Report and Financial Statements were then approved. Proposed by Rhona Polak and seconded by Yvonne McDonald

4.2 <u>Resolution in Terms of Rule 74 to Approve the Appointment of Auditors for the Financial Year 2019/2020.</u>

Rhona Polak informed all present that it is Knowes' Audit Policy to formally procure our external audit function after an audit firm has been in post for 7 consecutive years. Therefore as our current auditor, Alexander Sloan's 7 year tenure has come to an end in financial year 2018/19, we went out to tender for the audit function in July.

After detailed evaluation of the tender returns, we are pleased to report that Alexander Sloan again submitted the winning bid. Therefore the Management Committee propose that Knowes' members pass a resolution to reappoint Alexander Sloan as the external auditors for 2019/20 as per Rule 74 and Knowes Audit Policy.

Proposed and accepted by Gary Clarke and seconded by Sheila Cope.

5.0 <u>Directors Presentation</u>

Pierre De Fence, our Director then gave his short presentation.

Pierre advised that this is our sixth year of reporting against the Scottish Social Housing Charter and our first year of providing an annual assurance statement, both of which are on our website.

Pierre reported on the Association's performance this year against the averages of other RSL's in the same time period, which included the following:-

 Our rent increase this year was 2.60% against a Scottish average for all RSL's of 3.21%

We surveyed approximately 200 of our tenants and of the tenants who responded to our tenant satisfaction survey, the results were as follows:-

- 91% said they were satisfied with the overall service we provided compared to the Scottish average of 90.1%
- 94% felt that we were good at keeping them informed about services etc., with the Scottish average being 91.6%
- 89.1% were satisfied with the opportunities we offer to participate in our decision making, compared to the Scottish average of 86.5%
- 96.8% of Knowes stock meets the Scottish Housing Quality Standard against the RSL average of 94.1%
- The average length of time taken to complete emergency repairs was approximately 0.9 hours, the Scottish average was 3.6 hours
- Our repairs appointment service is working very well, 100% of appointments were kept, compared to the Scottish average of 95.6%

Neighbourhoods

 85.4% of reported anti-social behaviour complaints were resolved within agreed targets, compared to the Scottish figure of 87.9%

Value for Money

- The amount of money Knowes collected for current and past rent was equal to 99.4% of the total rent it was due in the year, the Scottish average was 99.1%
- 0.2% of rent was not collected due to empty homes, the Scottish average is 0.9%
- Knowes took an average of 7.4 days to re-let homes, the Scottish average was 31.9%

What Happened During The Year

- Ofgem came to visit us to see the great work we have done in energy saving measures, which resulted in Knowes being mentioned in the Scottish Parliament
- Once again McDougalls sponsored our annual bus trip for our more mature residents
- A local young man started an apprenticeship with the McDougal Group
- Two of our staff went off on maternity leave and have new additions to their families
- Our painting contractor The Bell Group organised a paint giveaway day which was so successful they had to go back to their base for more supplies
- Knowes helped sponsor the Gala Day and assisted in judging "Faifley's Got Talent"
- We also helped to publicise the work being done to uncover the famous Faifley "rock art"

Pierre completed his presentation by looking at what lies ahead for Knowes.

- Universal Credit is being rolled out and over 100 of our tenants have been moved onto it
- We continue to work with WDC and the Scottish Government and are hopeful of securing the Bowling Club site to develop and build new properties
- We continue to try and reduce fuel poverty and carbon emissions
